- Laminated blue woven fabric – composition: 100% Nylon® with ePTFE coating .
- White padding – composition: 65% Polyolefin / 35% Polyester.
- Grey woven fabric (lining) – composition: 100% polyester.
- Yarn for stitching.

The PPE is available in the following sizes: 8/S, 9/M, 10/L, 11/XL, 12/XXL and 13/3XL.

The PPE is available with the following variants:

- WR_WP: Short gloves made in blue color with elastic cuffs
 - Black elastic knitted fabric (cuffs): 100% Nylon®.
- EB_WP: Large gloves made in blue color.
- SH_WP: Large gloves made in blue color (covering to the elbow).
- P-MA_WP: Gloves made in pink color.
- P-WR_WP: Short gloves made in pink color with elastic cuffs
 - Grey elastic knitted fabric (cuffs): 100% Nylon®.
- P-EB_WP: Large gloves made in pink color.
- P-SH_WP: Large gloves made in pink color (covering to the elbow).

It shall be the manufacturer's responsibility to provide specific information of this certificate and the tested levels of protection.
