In addition with one exception the PPE satisfied the requirements of EN 1073-2:2002 (Protective clothing against particulate radioactive contamination - Non-ventilated clothing) with a performance classification of TIL Class 2. The exception is that clause 4.2 specifies that the minimum puncture resistance should be class 2, but the fabric used has a puncture resistance classification of class 1.

This certificate is issued on the strict condition that appropriate checks on manufactured PPE, as detailed in Article 19 (c) of the Regulation are implemented and maintained while the model is in production.
