- **General protective and hygienic measures**  
The usual precautionary measures should be adhered to when handling chemicals.
- **Breathing equipment:** Suitable respiratory protective device recommended.
- **Protection of hands:**  
The glove material has to be impermeable and resistant to the product/ the substance/ the preparation.
