1. PRODUCT NAME BAMBANKER[®]Direct (Serum-Free Type Cell Freezing Medium)

2. HAZARDS IDENTIFICATION

Dimethyl Sulfoxide (DMSO) is contained in this product.

3. FIRST-AID MEASURES

EYE CONTACT: Remove any contact lenses at once. Flush eyes well with flooding amounts of running water. Assure adequate flushing by separating the eyelids with sterile fingers. If irritation persists, consult a ophthalmologist.
